- 2. Shares sold pursuant to a Rule 10b5-1 trading plan enter into on February 28, 2024.
- 3. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$20.15 to \$20.60 inclusive.
